

## 2023-24 Summer Aid Application Form

Degree-seeking **undergraduate students** who register for at least half time (6 credits) during the summer term at TXWES are eligible to receive student loans, federal grants (if eligible as determined by your FAFSA, and if you have not reached your maximum Pell eligibility of 600%), and possibly academic scholarships. Undergraduate students who are enrolled in less than six credits and are eligible for the federal Pell Grant will be eligible to receive this grant and possibly academic scholarships.

**Graduate students** who register for at least half-time (5 credits, some programs are less) during the summer term at TXWES are eligible to receive student loans. **DNAP students do not need to complete this form.** 

• When a student receives financial aid for the summer term, this could affect the amounts to be received for fall and spring terms.

**Example:** A student is eligible and was offered a Federal Direct Loan of \$5,500 for the academic year (\$2,750 for the fall and \$2,750 for the spring). The student enrolls for six credits for the summer term and now the \$5,500 will be divided between 3 semesters instead of 2 and they will be awarded \$1,833 for Summer, Fall, and Spring.

• Most aid offered is based on full-time enrollment and if fewer classes are taken, the student will be eligible for a decreased amount.

**Example:** A student is offered a \$7,000 academic scholarship but only registers for 6 credits, they will be eligible to receive only \$3,500 based on half-time enrollment.
