Texas Wesleyan University's Undergraduate Education provides teacher candidates with degree programs leading to EC-6 Generalist with ESL Certification, EC-6 Bilingual, Secondary (English, History, Mathematics, Science) and All Level (Music, Spanish). This department has offered some form of elementary Bilingual certification since 1968. The department certified 20 to 30 EC-6 Bilingual pre-service teachers each year until 2013. That number was greatly reduced due to the expiration of a grant for Bilingual certification. Application for a new Bilingual grant has been submitted. Most students in the teacher certification programs are first-generation college students who transfer from area community colleges such as Tarrant County (TCCD), Dallas (DCCD), Hill, and Weatherford Community Colleges. At the graduate level, Texas Wesleyan University also offers programs leading to certification in School Administration, Reading Specialist, Gifted and Talented and School Counseling.
